Pioneer in Pharmacy



Dr. Madhabhai M. Patel (M. Pharm., L.L.B., Ph.D.)

A Renowned educationist and eminent scientist in the field of Pharmaceutics, was born on August 18, 1951. He obtained his early education in small village Palaj of district Mehsana in north Gujarat. He got B. Pharm (April 1975) with second class and M. Pharm degree (April 1977) with first class from L. M. College of Pharmacy, Gujarat University, Ahmedabad. He had completed his LL.B. (Labour law) in Oct.1979 from Gujarat University, Ahmedabad, Gujarat, and Ph. D. (April 2003) from North Gujarat University, (NGU) Patan, North Gujarat.

Prof. Madhabhai M. Patel started his carrier as assistant lecturer (July 77 to November 1982), Lecturer (November 82 to November 1988), Lecturer senior scale (November 1988- August 1992), Lecturer selection scale (August 1992- December 1993), Dt., Asst. Professor (January 1994- March 1998) in L.M. College of Pharmacy, Ahmedabad, Gujarat.

With a view to serve the pharmacy profession with academic carrier, he joined S. K. Patel College of Pharmaceutical Education & Research, Ganpat Vidyanagar as Principal and Proffessor. (April 1998-June 2007). He became I/c Vice Chancellor (May 2003- Jan 2005) and the Vice chancellor of North Gujarat University (Jan 2005- July 2006). This was for the first time that a person from pharmacy field has worked on this post in Gujarat and second in India. Presently he is working as principal at Kalol Institute of Pharmacy, Kalol.

He is the approved PG teacher in Pharmaceutic and Pharmaceutical Technology at Gujarat University, Ahmedabad and HNGU, Patan. He is approved Ph. D. Guide of Hemchandracharya North Gujarat University, Patan, Ganpat University, Kherva, Sumandeep Vidyapeeth University, Waghodia, Vadodara, Jodhpur University, Jodhapur (RAJ.), Kadi Sarva Vishwavidyalaya, Gandhinagar, and Dharmsinh Desai University, Nadiad. Fifty research scholars have been registered for their Ph.D work out of which 35 have been awarded Ph. D degree. Being a great administrator, with simplicity, honesty, humanity, noble qualities and concern for every individual, he could inspire the staff, as well as students, to work hard with a team spirit and offer their best to the pharmacy profession and pharmacy department. Several scientific organizations and professional bodies were immensely benefited with his association. He is the expert member of pharmacy council of India (PCI) and NBA-AICTE, New Delhi.
